The notes on the following pages give an explanation of the proposed resolutions. Resolutions 1 to 7 are proposed as ordinary resolutions. This means that for each of those resolutions to be passed, more than half of the votes cast must be in favour of the resolution. Resolution 8 is proposed as a special resolution. This means that for each of those resolutions to be passed, at least three-quarters of the votes cast must be in favour of the resolution.

#### Resolution 1

The directors of the Company ("Director" and together the "Board") will present their report and the audited accounts for the year ended 31 December 2023 together with the auditor's report thereon.

#### Resolutions 2 to 4
